

1. Program Eligibility

To be eligible for this extended boat use program offered by the FYC Sailing School (FYCSS), participants shall:

1. Be FYCSS adult students, sailing at the CANSail Level 2 or above, with guests at their discretion.
2. Show competency in sailing and sailing at a CANSail 2 Level as determined by the sailing instructors.

This eligibility shall continue for the remainder of sailing season in the year of graduation only.

2. Program Terms

1. Boats that may be used are the FYCSS CL14s, RS Quests, and RS Fevas, when not in use by the FYCSS.
2. Keys are for your use only and may not be shared. All keys issued shall be returned to the Club for return of the key deposit amount.
3. Participation in this program does not constitute any form of membership at the Fanshawe Yacht Club.

3. Program Rules

These rules are **in addition** to the rules outlined in the separate document titled “Sailing School Boat Use Rules”.

All participants shall abide by these program-specific and the boat use rules at all times:

1. Participants will not sail any boat in wind or gusts forecasted above 25 km/hr (14 knots), as per the Sail Flow weather forecast available on the home page of the Fanshawe Yacht Club web site (www.LondonSailing.ca).
2. Participants may only have onboard guests who are physically and mentally able to handle the demands of sailing. There is a limit of three (3) people total per boat.

Failure to follow these rules and the boat use rules will result in withdrawal of boat use privileges with no refund.

4. Liability Release

Participants shall agree to the following liability release:

In consideration of acceptance of my registration in the FYC Adult Student Boat Use Program, I agree to save harmless and keep indemnified the Fanshawe Yacht Club and its Sailing School, the Ontario Sailing Association, Sail Canada, their organizers and respective agents, officials, staff and representatives from and against all claims, actions, cost, expenses and demands in respect to death, injury, loss or damage to any person or property, howsoever caused, arising out of or in connection with my taking part in this Program. I further understand and agree that this release is binding on myself, my heirs, my executors and assigns.

I also understand and give permission that photographs and video taken at the Fanshawe Yacht Club and/or the Sailing School may be used for promotional purposes by the Fanshawe Yacht Club and Sailing School.

I have read the above **Boat Use Program Eligibility, Terms and Rules** and agree to abide by them.

I have read the **Sailing School Boat Use Rules** (separate document) and agree to abide by them.

I have read the above **release** and agree to abide by the conditions.
